

# Letter Calling on the DEP and Gov. Wolf to Pause All Drilling Near Marsh Creek Lake, Allow for Comprehensive, Independent Investigation

Calls from residents in Upper Uwchlan township poured into my office late last Tuesday afternoon with reports of drill sounds off of Park Road. I later received confirmation from the DEP that Sunoco Pipeline, L.P. (Energy Transfer) had resumed horizontal directional drilling (HDD) at drill site HDD# S3-0300, located on the same easement as the August 10<sup>th</sup> inadvertent return (IR) incident at site HDD# S3-00290 that resulted in thousands of gallons of industrial waste spewing into Marsh Creek Lake, a 15 foot wide sink hole, and violations of the Clean Stream Law.

Sunoco has yet to submit an Interim IR report as required by the DEP, and results of investigation from other state entities have not yet been completed. My constituents are understandably extremely concerned and very distressed regarding the long-term environmental impacts caused by this event. As such, I strongly request that the DEP hold a public meeting to discuss environmental damage, forthcoming mitigation efforts, and the necessary thresholds required for consideration of any possible restart of construction activities.

In a <u>letter</u> to DEP Secretary McDonnell, I also requested that the following requirements be included in the ongoing DEP investigation into environmental harm:

- A full and comprehensive report containing complete hydrological, ground water, and geophysical associated data in proximity to the HDD 0290 drill site, pipeline easement, sinkhole, and surrounding headwaters of the Marsh Creek Lake.
- An independent content analysis supervised by an impacted municipal entity or the Attorney General's office of any and all drilling fluid utilized during HDD construction including, but not limited to, super sacks, super gel x, and bentonite.
- An independent content analysis of any and all grouting material utilized to stabilize
  the 15 foot wide and 8 foot deep wetland sinkhole which occurred following the most
  recent IR contamination event on August 10, 2020.



- A full and comprehensive report containing complete hydrological, ground wa and geophysical associated data in proximity to the HDD 0290 drill site, pipel easement, sinkhole, and surrounding headwaters of the Marsh Creek Lake.
- An independent content analysis supervised by an impacted municipal entity or the Attorney General's office of any and all drilling fluid utilized during HDD construction including, but not limited to, super sacks, super get x, and bentonite
- An independent content analysis of any and all grouting material utilized to stabilize the 15 foot wide and 8 foot deep wetland sinkhole which occurred following the most report IB contamination general on August 10, 2020.

Further, it has come to my attention that Sunoco has recently initiated construction activity at a nearby drill site, HDD 0300. I am extremely concerned as this drill site is located immediately adjacent to the most recent IR and sinkhole that occurred on August 10 at HDD 0290. I question the decision to allow Sunoco to resume construction that logically has a shared geology and therefore, may result in similar harm to Marsh Creek Lake. In fact, in Sunoco's Response to DEP Comments for HDD Re-Evaluation Report dated February 4, 2020, Sunoco acknowledged the regionally shared geological features and relied, in part, on geophysical studies at both HDD 0290 and HDD 0300 to justify the resumption of construction at HDD 0300. With this in mind, I strongly urge the Department to prohibit drilling activities at HDD 0300 until a comprehensive review of the geological conditions in this region can be adequately analyzed.

Finally, my constituents are understandably extremely concerned and very distressed regarding the long-term environmental impacts caused by this event. As such, I strongly request that the Department hold a public meeting to discuss environmental damage, forthcoming mitigation efforts, and the necessary thresholds required for consideration of any possible restart of construction activities. This meeting should include, at minimum, appropriate and knowledgeable staff from the DEP, the Department of Conservation and Natural Resources, the Public Utility Commission, the Chester County Conservation District, the Chester County Department of Health, and Sunoco.

I thank you for your time and attention to this serious and ongoing environmental issue in my Senate District. If I can assist in coordinating the public meeting or provide any clarification to these requests, please do not hesitate to confact me.

### Mail-In vs Absentee Ballots

We have 64 days until election day! Our office has received a lot of calls regarding ballot confusion.

Mail-in and absentee ballot **applications** for the November 3, 2020, general election must be received by your county election office by 5 p.m. on Tuesday, October 27, 2020.

Mail-in ballot – Any qualified voter may apply for a mail-in ballot. You may simply request this ballot without a reason.

Absentee ballot – Still requires you to list a reason for your ballot (this applies to college students, members of the military, inmates who have not been convicted of a felony, or those with a physical disability)

In order to request either ballot type, you must be registered to vote.

It is highly recommended that if you want to vote by mail that you submit your

application as soon as possible and mail back your ballot shortly after receiving it.



Census Bureau Ending Counting Efforts Early


The Census Bureau is ending all counting efforts for the 2020 census on Sept. 30, a month sooner than previously announced. Senate District 44 sits at only 79.3% and for every person not counted we risk losing pearly \$2,100 in federal dellars.

For the next 10 years, the federal government will rely on the collected 2020 census data to help guide distribution of approximately \$1.5 trillion in annual spending across 316
