On Sunday morning I was honored to be in attendance for the assumption of command ceremony for Colonel Deane E. Thomey at Biddle Air National Guard Base in Horsham. Colonel Rebecca Gray was also introduced as the Vice Commander of the 111th Attack Wing and is responsible for assisting the commander with supervising the wing and its subordinate units.

My Vote On HR106 On Wednesday evening, Senate session was extended to push through <u>HR106</u>, which

ends the emergency declaration. Doing so put in immediate jeopardy access to federal sources such as the expanded SNAP program, school lunches through the summer, and the ability to use federal funds for use of the national guard. Suddenly realizing that ending the emergency declaration would eliminate waivers that

have improved the lives of Pennsylvanians, the Senate approved House Bill 854 on Thursday, which ensures all waivers previously effective under the COVID-19 emergency to remain in effect until Sept. 30, 2021, unless sooner terminated. I'm baffled that so many resources have been spent to stick it to the Governor, instead of

working together to improve our response to the next pandemic. We have an opportunity to reinvest in the people of Pennsylvania and help those who continue to suffer as a result of the pandemic. Instead, too many legislators in Harrisburg want to act as if the pandemic never happened and leave behind their constituents who they were elected to serve.

Investing in Public Education: Fair Funding

People are sick and tired of rising property taxes and for years the Majority party in the General Assembly has failed to live up to their responsibility to provide sufficient state funding for public schools, while passing the buck to local school districts to make up the difference.

Navigating the New UC System

My office is aware of issues that constituents are having when trying to log on to the new UC system. While we are working with the individuals and L&I to address some of the concerns, below is some information that we received:

- L&I is actively reviewing feedback from individuals using the new system and has identified two areas where several users have had questions. The first is that multiple users who receive payments by direct deposit have reported seeing their payment type listed as "debit card." Because payment data is stored primarily by the Pennsylvania Treasury and not the UC system, this is just a display issue and is not a problem with payment type. After a person's payment is made, the correct payment method will be displayed. Users do not need to take any action to correct this should they see "debit card" listed instead of direct deposit.
 L&I is also aware that a small percentage of users are experiencing an issue logging
- in with their Keystone ID or when they attempt to change their payment type. This issue has been identified as being related to server connectivity, and a fix is already underway.

 L&I has also posted topic-specific video walkthroughs relative to many of the most

frequently asked questions that can be found <u>here</u>.

Public Hearing June 16: Mariner East 2
(Marsh Creek Lake)

The PA DEP is holding a virtual public hearing on June 16th regarding amendment

applications for the Mariner East 2 pipeline. Sunoco is requesting a modification from HDD (horizontal directional drilling) to an open-cut trench for the installation of this segment of the pipeline, as well as a revised route that requires cutting through streams that feed Marsh Creek Lake.

Drilling fluid spilled on August 10th, remains in Marsh Creek Lake at this moment,

requiring that a section of this state park is closed to visitors. In addition to being a community recreation destination, Marsh Creek Lake is also an important drinking water source for Chester County residents.


