The COVID-19 public health crisis has impacted every Pennsylvanian in every community. The recently enacted state budget includes \$2.6 billion in federal stimulus funds through the Coronavirus Aid, Relief, and Economic Security Act (CARES).

As a result, the Department of Community and Economic Development was allocated \$225 million for COVID-19 relief for small businesses through a distribution to **Community Development Financial Institutions** (CDFIs).

DCED will distribute the funding to the Pennsylvania CDFI Network, which will then administer the funding in the form of:

 Grants to cover operating expenses for the duration of the shutdown and the transition period to re-opening

- Grants to cover technical assistance, including training and guidance, for business owners as they stabilize and relaunch their businesses
- Loan loss reserves for CDFIs

Debt payment relief for CDFI Pennsylvania borrowers

The funds will be distributed in three ways:

 Main Street Business Revitalization Program: \$100 million Historically Disadvantaged Business Revitalization Program: \$100 million

- Loan payment deferment and loss reserve: \$25 million



My Statement on HR836 to Preserve the

Governor's Emergency Declaration Last week, I was a NO vote on HR836, which effectively would end the Governor's emergency disaster declaration. This resolution would NOT affect the Secretary of Health's order including business closure orders, building safety orders, and business

safety orders, which therefore ultimately means that the phased reopening plan

I have heard from many of my constituents on both sides of this issue and I appreciate the dialogue that we have been able to have to address the many concerns that the pandemic has had on all Pennsylvanians. I was not willing to sacrifice aid that the emergency disaster proclamation affords the state from the federal government, which aims to help Pennsylvanians and businesses by means of:

Unemployment Compensation eligibility requirements and employer relief from charges.

Property tax relief.

Educational tax credit waivers.

Certification requirements under the public-school code and child protective services law.

As a result of ending the disaster proclamation, we received no assurance that the state would continue to be eligible for federal public and individual disaster assistance, and any additional state funding available through General Fund dollars. I will continue to work with the administration to advocate for the southeastern regions fair share of relief aid to help hardworking Pennsylvanians and businesses that have suffered the most, while we all work together to take responsible precautions to limit a resurgence of the virus.

Ending Systemic Racism and Oppression

<u>Last week</u>, I urged my colleagues in the Senate to take urgent action to pass legislative solutions to end systemic and institutional racism and oppression. For decades, black and brown communities have suffered and they need to be heard.

The PA General Assembly has tremendous power to enact legislative solutions that could change lives, but instead, the willful ignorance and disregard for black and brown lives continues to plague our democracy. Racism is truly undermining and crumbling our society.

The PA Senate Democratic Caucus has introduced a number of bills relative to police reform including No consent in custody, Banning chokeholds and positional asphyxia, <u>Training and accountability</u>, and Requiring civilian police review boards to name a few. 
